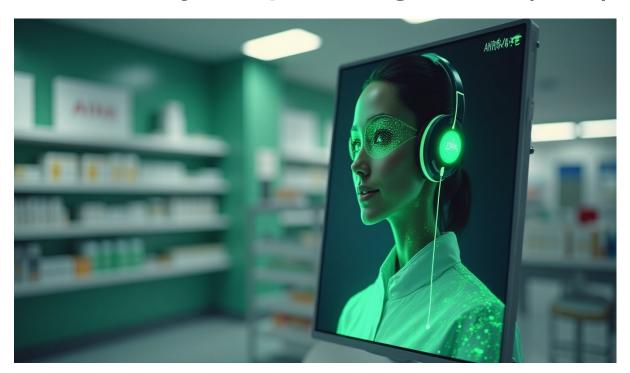

Pharmacy First – Sore Throat Module (v1)

1. Overview

The AIVAe Early Adopter Programme (EAP) is a **select pilot cohort of 10 community pharmacies** who will gain early access to AIVAe's *Pharmacy First Sore Throat Workflow Engine (v1)* before wider rollout.

The purpose of the programme is to:

- Validate the structured clinical workflow
- Reduce consultation/documentation time
- Improve PGD compliance and safety
- Reduce variation between pharmacists/locums
- Demonstrate measurable impact for ICBs and commissioners
- Shape the future direction of Pharmacy First digitisation

AIVAe v1 is built on **deterministic clinical logic**, with no Al-driven decision-making. LLM use is restricted to **SOAP note generation and safety-netting narrative** only.

2. What Early Adopters Receive

A. Early Access to AIVAe PF v1

- Full workflow for **Sore Throat** (Centor, red flags, PGD eligibility, outcome engine)
- Automatic SOAP note generation
- PDF export for PharmOutcomes documentation
- Override capture for red flags
- · Secure login and user management

B. Direct Collaboration With the Founder & Clinical Team

- Weekly 15–20 min check-ins
- Fast turnaround on feedback
- · Ability to influence design decisions
- Direct channel to ask questions, request changes, and test new iterations

C. Pilot Support Pack

- Getting Started Guide
- Data collection sheet (optional)

- Governance & safety overview
- DPIA template (if required)
- Pilot SOP addendum (optional)

D. Preferential Pricing

After the pilot, early adopters will receive:

- Discounted pricing for 12 months, and
- First access to new PF modules (UTI, sinusitis, ear pain, insect bites, shingles, impetigo)

3. What We Ask From Early Adopters

A. Regular Use During the Pilot (6–8 Weeks)

Aim: 5+ Sore Throat consultations/week
(Or as many as your pharmacy receives naturally)

B. Weekly Feedback

- 15–20 minutes by phone or Zoom
- What worked
- What needs improvement
- Any clinical/safety concerns
- What slows you down

C. Allow Us to Collect Anonymous Metrics

Examples:

- Time spent per consultation
- Documentation time
- Outcome type
- Red flag rates
- Pharmacist satisfaction

(No patient-identifiable data is collected by AIVAe.)

D. Optional: Provide a Testimonial or Case Study

This helps us demonstrate impact to:

- NHS England
- ICB pharmacy teams
- Other pharmacies
- Investors

4. Pilot Timeline

Week 1

- Onboarding call
- Quick training
- First test consultation (dummy or real)

Week 2-3

- Regular use
- Weekly feedback
- Rapid iteration by our team

Week 4-6

- Continued use
- Feature refinements
- Outcome and usage data collection

Week 6-8

- End-of-pilot review
- Optional testimonial or case study
- Preferential pricing offered
- Decision on continued use

5. Selection Criteria (Who We're Looking For)

We are selecting pharmacies that have:

- Good patient flow
- Active participation in Pharmacy First
- Interest in digital innovation
- Willingness to test structured workflows
- Pharmacists happy to give honest feedback
- Some locum usage (preferred)
- Desire to reduce documentation burden

Ideal participants include:

Independent community pharmacies

- Small chains (1–10 sites)
- DSPs with strong clinical service output
- Pharmacies in PF high-demand areas
